### RULES OF PARTICIPATION

Artists may submit up to three works. Notification will be via email. Non-selected items must be picked up by Saturday, April 23. Pieces accepted into the show must be picked up between Tuesday, May 17 and Saturday, May 28. All pick-ups must occur during regular gallery hours (not including opening reception).

The entry fee is \$15 for one piece, \$20 for two, and \$30 for three. **Juried show fees are not refundable.**

You can pay online at [www.squareup.com/store/artistscorner](http://www.squareup.com/store/artistscorner), or by cash, check, or credit card when you drop off your artwork.

All artwork must be for sale. Artists will receive 60 percent of the sale price of any work that is sold.

All artwork **MUST** be suitably framed and securely wired for hanging. No sawtooth hangers or sandwich/clip frames.

All artwork **MUST** have labels attached with the artist's name, email, telephone number, title, medium, and price of the piece.

**We cannot accept work that does not meet these specifications.**

Two dimensional works must not exceed width + height of 72". Three dimensional works must not exceed width + height + length of 72". Artwork may not exceed 48" in any direction (including frame and display).
